

## **TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD REVIVAL 2025 VW TYPE 2 TRACK PARADE PRIZE DRAW.**

The terms and conditions set out in this section apply to all of the prize draws and draws operated by the Goodwood Group. Additional terms and conditions are included in Section 2.

### **1. WHO IS PROMOTING/SPONSORING THIS PRIZE DRAW?**

### **2. CAN I ENTER?**
