

## Terms and Conditions Applicable to the GRRC & Fellowship Refer a Friend Scheme

The terms and conditions set out in Section One apply to all of the schemes operated by the Goodwood Road Racing Company which is operated by the Goodwood Road Racing Company Limited ("Goodwood"), whose registered office is at Goodwood, Chichester, West Sussex PO18 0PX, company number 466176. You can contact Goodwood at this address.

Additional Terms and Conditions for each individual scheme are included in Section Two.

The terms and conditions set out in Section One and Section Two are referred to as the "Rules" and this promotion will be simply referred to as the "Scheme" throughout the rest of these Rules.

In these rules, "we," "our," and "us" refer to Goodwood and "you" and "yourself" refers to an eligible Scheme entrant.

### Definitions and Interpretations

**Fellow / Fellowship** means an individual who is on the waiting list to become a Member of the Goodwood Road Racing Club.

**Goodwood Road Racing Club or 'GRRC'** means the community of motorsport enthusiasts who are members of the GRRC.

**Member** means an individual who has a GRRC membership.

**Scheme** means this refer a friend promotion.

## Section One: General Terms

### 1. Who is promoting/sponsoring this scheme?

The promoter and sponsor of this scheme is Goodwood.

### 2. Can I enter?

- Must be a current Goodwood Road Racing Club Member or Fellow.
- Legal resident of the United Kingdom, 18 years or older.
- You are not an employee or immediate family member of an employee of Goodwood Group companies.
- You are not involved in the administration and execution of the Scheme.

### 3. Rules about entry

- One entry is permitted per new GRRC Fellow referred.
- Scheme entries must comply with the method and period specified in Section Two.
- We reserve the right to disqualify any entrant for breach of these Rules.

### 4. How are winners selected and notified?

- Eligible recipients must be current GRRC or Fellow members.
- The referrer must share the bespoke referral link or referral form with the non-Member to complete, and the non-Member must join the GRRC Fellowship before the referrer may receive their prize.

#### Referral criteria:

- a) The non-Member must be a first-time GRRC Member or Fellow.
- b) The gift needs to be selected within one month of the new Fellow joining.
- c) The new Fellow is required to put the referrer's details on the application form when joining. This cannot be backdated afterwards.
- d) The referrer must maintain an active membership with no outstanding fees. The new Fellow must pay in full on joining.

We reserve the right to modify or terminate the Scheme at any time.

### 5. Rules about prizes

## **6. What other conditions am I agreeing to by entering this Scheme?**

- The provisions of the Contracts (Rights of Third Parties) Act 1999 shall not apply to this agreement.

## **8. What if something unexpected happens and the Scheme can't run as planned?**

- If a virus, catastrophic event, or any other unforeseen or unexpected event that cannot be reasonably anticipated or controlled, (also referred to as force majeure) affects the fairness and /or integrity of this Scheme, we reserve the right to cancel, change or suspend this Scheme.

## Section Two

### Terms and Conditions Applicable to the GRRC & Fellowship 80MM Refer a Friend scheme (April 2023)

The terms and conditions set out in this section apply to the Goodwood Road Racing Company Limited's GRRC Membership and Fellowship. Additional terms and conditions applicable to all schemes are included in Section One.

#### 1. When will the scheme take place?
